



# Rules of the XXXVI International School of Hydraulics payment at [sh.igf.edu.pl](http://sh.igf.edu.pl) website

1. The organizer of **the XXXVI International School of Hydraulics** and **sh.igf.edu.pl** website owner the Institute of Geophysics, Polish Academy of Sciences, seated at 64 Księcia Janusza Street, Warsaw, hereinafter referred to as the "Organizer".
2. The Organizer may be contacted in person at the Organizer's office, or by regular mail sent to the Organizers' postal address, and also by electronic mail sent to **sh@igf.edu.pl**
3. The financial service of **the XXXVI International School of Hydraulics** conferences shall be ensured by the Institute of Geophysics, Polish Academy of Sciences, seated in Warsaw at 64 Księcia Janusza Street.
4. To participate in the conference, one is required to register at **sh.igf.edu.pl** and pay a fee to the Organizer within the time limit defined at **sh.igf.edu.pl**. The person who paid the XXXVI International School of Hydraulics conferences fee shall be hereinafter referred to as the "Participant".
5. The XXXVI International School of Hydraulics participation fee is to be paid by payment card.
6. The **sh.igf.edu.pl** website reserves the right to make available other forms of payment than the above mentioned, based on individual arrangements with Participants.
7. The online payments shall be serviced by eCard S.A. and the available payment forms shall include the following payment cards:
  - a. Visa,
  - b. Visa Electron,
  - c. MasterCard,
  - d. MasterCard Electronic,
  - e. Maestro.
8. Each Participant shall have the right to withdraw from the contract for convenience within 10 (ten) days from conference fee payment, as per art. 7 section 1 of the law of 2 March 2000 concerning protection of certain consumer rights and liability for damage caused by a hazardous product (Journal of Laws of 2000 No. 22, item 271, as amended).

9. **Before April 30<sup>th</sup> 2017** each Participant shall have the right to withdraw from participation therein.
10. If the withdrawal takes place **before February 10<sup>th</sup> 2017**, the conference fee paid for participation in the XXXVI International School of Hydraulics conferences, less an administration fee of **200 PLN/50 EUR**, shall be reimbursed to such a Participant within 14 days from the date of receiving by the Organizer a written statement of withdrawal from the conference participation by such a Participant. In case of a payment card the amount shall be reimbursed directly to the Client's card. If such a withdrawal takes place **after February 10<sup>th</sup> 2017** and **before April 30<sup>th</sup> 2017**, the conference fee of **50%** of its value shall be reimbursed to a Participant. **After April 30<sup>th</sup> 2017** and/or the Participant fails to attend the conference, the conference fee shall **not be reimbursed**.
11. Any complaint shall be examined within 14 business days at the latest, counting from the date of receipt of the complaint by the Organizer.
12. Should the Organizer fail to take a stand as regards the complaint filed by a Participant within 14 business days counting from the date of receipt of the complaint by the Organizer, it shall be assumed that the Organizer found the complaint justified.
13. The Organizer shall assure that personal data of Participants are processed only for the purpose of implementation of the XXXVI International School of Hydraulics conferences.
14. The Organizer shall neither process nor make any data concerning Participants available to other entities.
